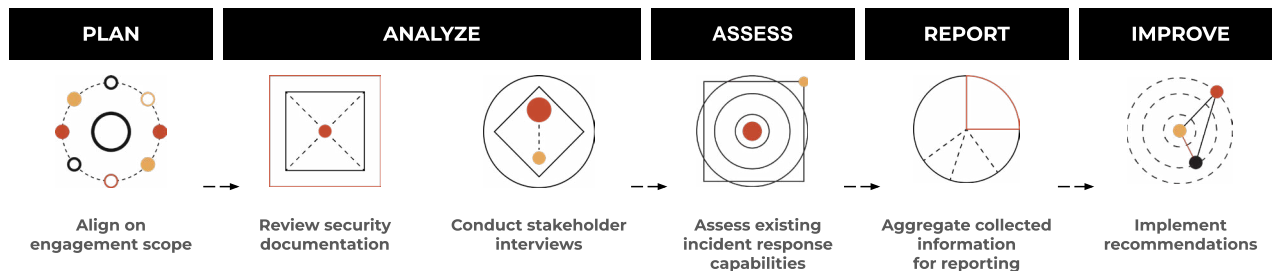


Figure 1: Unit 42 Breach Readiness Review methodology
